

EFFCU 2024 [SWIPE & WIN SWIPESTAKES SWEEPSTAKES OFFICIAL RULES](#)

NO PURCHASE, OBLIGATION OR TRANSACTION NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING. ODDS OF WINNING DEPENDENT ON NUMBER OF ENTRIES.

1. ELIGIBILITY:

The EFFCU 2024 "Swipe & Win Sweepstakes" Sweepstakes ("Sweepstakes") is only offered in Texas and entrants must be legal U.S. residents, 18 years of age or older as of March 1, 2024, excluding residents of Florida, New York, Rhode Island, Washington D.C., Puerto Rico and where otherwise prohibited. Employees, volunteer committee members, and the Board of Directors of EFFCU ("Sponsor"), its subsidiaries, affiliates, distributors, advertising and promotion agencies and their immediate family members (defined as spouses, children, parents, siblings, in-laws) and those living in their households are not eligible. Void where prohibited or restricted by law. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

2. TIMING:

The Sweepstakes begins at 12:00:01 a.m. Central Daylight Time ("CDT") on March 1, 2024, and ends at 11:59:59 p.m. CDT on June 30, 2024 ("Promotional Period").

3. HOW TO ENTER:

There are two (2) ways to enter during the Promotional Period:

1) **Automatic Entry:** Eligible EFFCU debit and credit cardholders automatically receive one entry with every non-PIN-based purchase transaction using any of the following EFFCU totalREWARDS VISA® credit or debit cards:

- EFFCU totalREWARDS VISA debit card
- EFFCU totalREWARDS VISA credit card
- EFFCU totalREWARDS VISA Business debit card
- EFFCU totalREWARDS VISA Business credit card

Purchase(s) must be made by the end of the Promotional Period. Account adjustment transactions, returns, late payment fees, unauthorized transactions, Cash Advances, Balance Transfers, and/or other fees assessed on your account are not considered eligible transactions for automatic sweepstakes entry. Use of credit cards is subject to the terms of the Credit Card Agreement and Disclosure Statement.

2) **No-Purchase Necessary Method:** To enter without making a payment with Education First FCU totalREWARDS VISA debit card or credit card, fill out the [entry form](#). You will receive one (1) entry into the sweepstakes. All no-purchase necessary entries must be entered by June 30, 2024. All entries become the exclusive property of EFFCU, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by EFFCU. EFFCU is not responsible for late, incomplete, invalid, misdirected, which will be disqualified.

4. DRAWING:

There will be one (1) winner at the end of the Promotional Period. The winner will be selected by random drawing from all eligible entries within fifteen (15) business days of the end of the Promotional Period.

The decisions of the Sponsor are final and binding in all matters relating to the Sweepstakes.

5. ODDS OF WINNING:

The odds of winning depend upon the total number of eligible entries received during the Promotional Period.

6. PRIZE:

One (1) winner will receive a check or direct deposit to their EFFCU account in the amount of \$10,000 ("Prize"). No substitutions, cash equivalents or transfer of prizes permitted except at the sole discretion of the Sponsor. If the winner is part of a joint account or is an authorized user on the account, the individual listed as the primary account holder will be considered the winning entrant. Sweepstakes is subject to all applicable federal, state and local laws and regulations. Winner is responsible for the payment of federal, state and local taxes on the prize and for any other expenses not specified. Sweepstakes are void in Florida, New York, Rhode Island, Washington D.C., Puerto Rico and where otherwise prohibited by law.

7. NOTIFICATION:

The winner will be notified by telephone, email or certified mail (return receipt requested) within ten (10) business days after the drawing. EFFCU reserves the right to require a signed and notarized Affidavit of Eligibility and Liability Release each of which must be returned within ten (10) business days from the request by sponsor for such Affidavit or Release. The prize check will be sent via overnight courier (signature required) after the receipt of the signed and notarized Affidavit of Eligibility and Liability Release unless other arrangements are made and agreed to in writing by Sponsor and winner. If the winner elects to receive the winning prize via direct deposit to their EFFCU account, the total prize amount will be deposited within ten (10) business days to the winner's designated account after the receipt of the signed and notarized Affidavit of Eligibility and Liability Release, Direct Deposit Authorization Form, and W-9 unless other arrangements are made and agreed to in writing by Sponsor and winner. In the event of non-compliance with these rules, or if the prize or prize notification is unclaimed or returned as undeliverable, the prize will be forfeited and, at Sponsor's discretion, awarded to an alternate winner.

8. GENERAL CONDITIONS:

By entering the Sweepstakes, entrants agree to be bound by these Official Rules including all eligibility requirements and the decisions of the Sponsor which are final and binding. By entering the Sweepstakes, entrants agree to the use by Sponsor and its designees of their names, cities and states of residence and photographs/likenesses and voices for advertising and promotional purposes for this and similar promotions in perpetuity, in any and all forms of media, now known or hereafter devised (including and without limitation, the internet) without additional compensation, notification, or permission, except where prohibited by law. By entering the Sweepstakes, entrants agree that Sponsor may contact entrants for the purpose of administering the Sweepstakes only. All materials submitted, including Entries, become the sole property of the Sponsor and will not be returned. Potential winner will be notified by secure message, mail, phone and/or email and must complete, and return the notarized Affidavit of Eligibility/Release of Liability/Prize Acceptance Form, and (where legally permissible) a Publicity Release within ten (10) days of attempted notification. The winner's Affidavit Form is subject to verification by Sponsor. The awarding of the prize is contingent on each individual's full compliance with these Official Rules, as determined by Sponsor in its sole discretion. If winner is found to have falsified any data or material, the winner forfeits his/her prize and is disqualified, and an alternate winner will be selected according to the

original winner selection method, time permitting. If prize notification is undeliverable or if potential winner does not comply within the applicable time period as stated above, he/she will be disqualified and an alternate winner will be selected. Releases as defined below are not responsible if a Potential Winner does not receive the Winner Notification forms or corresponding Prize because a fraudulent email address or other inaccurate contact information was provided or if the email sent to a potential prize winner is misdirected or bounces back or is intercepted by spam or other email filters.

9. RELEASE AND LIMITATIONS OF LIABILITY:

Entrants agree to indemnify and hold harmless the Sponsor, its parent, affiliates, subsidiaries, divisions, advertising and promotion agencies, all of their respective employees, directors, officers, shareholders, agents, vendors, successors and assigns (collectively "Releases"), from any injuries, losses, damages, claims and actions of any kind resulting from or arising from participation in the Sweepstakes or acceptance, possession, use, non-use or misuse of the Prize that may be awarded. Releases are not responsible for printing, typographical, human or other inadvertent errors in any Sweepstakes-related materials or other errors relating to or in connection with the Sweepstakes, including without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of prizes; or for stolen, lost, late, corrupted, misdirected, damaged, incomplete, undecipherable entries; or for transactions that are lost, misdirected, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly or are lost for any reason, including computer, telephone, paper transfer, or human error or electronic, computer, or telephonic malfunction or error.

If, for any reason, the Sweepstakes is not capable of running as planned for reasons which may include without limitation time of war, national emergency, accident, dangerous weather conditions, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism, health crisis such as a pandemic or epidemic or other matters beyond the Sponsor's reasonable control (each a "Force Majeure" event), that corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Sweepstakes and the Sweepstakes is not capable of being conducted as described in these Official Rules, Sponsor shall have the right, at its sole discretion to cancel, terminate, modify or suspend this Sweepstakes in whole or in part, without further liability to the Entrants or third parties. In the event this Sweepstakes is cancelled prior to the stated end date, a notice will be posted at www.educationfirstfcu.org/policies-disclosures/swipe-and-win-sweepstakes-rules, and Sponsor reserves the right to award prizes in a random drawing from among all eligible non-suspect entries received prior to the time of the action or event warranting such cancellation.

If, in the Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, the Sponsor reserves the right at their sole discretion, to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify or suspend the Sweepstakes, or to terminate the Sweepstakes and conduct a random drawing to award the prizes using all transactions and entries received as of the termination date. Sponsor reserves the right to prosecute any individual suspected of tampering with the entry process to create fraudulent entries or to disrupt the operation of the Sweepstakes. Sponsor reserves the right at its sole discretion to disqualify any entrant to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in an

unsportsmanlike or disruptive way, or with intent to annoy, abuse, threaten or harass any other person.

Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that or any other provision.

10. PRIVACY & PERSONAL INFORMATION:

Personal information collected from entrants will be used by Sponsor for the purpose of administering the Sweepstakes only. Sponsor shall not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Sponsor to fulfill the above purposes. 11. DISPUTES:

Except where prohibited, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the United States and the State of Texas, without giving effect to any choice of law or conflict of law rules (whether of the State of Texas, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas. Each entrant consents to the jurisdiction and venue of the state or federal courts located in Jefferson County, State of Texas, in connection with any action, suit, proceeding or claim relating to this Sweepstakes.

Except where prohibited, as a condition of participating in this Sweepstakes, each participant agrees that any and all disputes that cannot be resolved between the participant and any Released Party, claims and causes of action arising out of or connected with this Sweepstakes, or the Prize awarded, or the determination of the winner must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will a participant be permitted or entitled to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees or other related legal expenses other than participant's actual out-of-pocket expenses (if any), and participant further waives all rights to have damages multiplied or increased.
